## NEW INSURANCE REQUIREMENTS FOR ANY CIVIL AIRCRAFT OPERATING FLIGHTS TO/FROM/WITHIN/OVER GEORGIA

**This AIC replaces AIC A 07/2019 dated 15 FEB 2019.**

This circular presents newly adopted rule by the Order No95 of the Director of the Georgian Civil Aviation Agency on the approval of "Insurance Requirements for The Holders of Air Operator Certificate or Operating License" which establishes minimum insurance limits for air carriers and aircraft operators while operating flights to/from/within/over Georgia in regards of passenger, baggage, cargo and third parties.

The information comes into force on 01 July 2017.

Ref: AIP GEORGIA GEN 1.2

All civil aircraft using airspace of Georgia must have insurance with the following minimum limits:

- a) **Passenger:**
  - i) for aircraft with MTOW less than 2700 kg or 2700 kg - 100 000 SDR;
  - ii) for aircraft with MTOW more than 2700 kg - 250 000 SDR;
- b) **Baggage** – 1131 SDR;
- c) **Cargo** – 19 SDR per kg;
- d) **Third party legal liability:**

An application for use of airspace of Georgia shall contain the following information:

- a) Name of an airline (three-letter designator), state of aircraft registration and address;
- b) Type and modification of an aircraft, its revenue capacity and maximum take-off weight (MTOW);
- c) Registration marks of a main and an alternate aircraft, owner of an aircraft (operator or leaseholder);
- d) Surname, name of a pilot-in-command of an aircraft, amount of crew members and their nationality;
- e) Purpose of flight, probable organizations (persons) in Georgia interested in the forthcoming flight;
- f) Category of flights (governmental, special, charter, technical or other); for governmental flights the rank and the name of a head of the delegation shall be stated;
- g) Flight number, radiotelephone or radiotelegraphy aircraft call signs;
- h) Aircraft load (number of passengers, weight of cargo and its nature);
- i) Date of flight and flight schedule (in) with indication of points of commercial and technical landings, as well as the amount of aviation fuel for fueling in the airports of Georgia;
- j) The airways, points and estimated time of entry into/leaving the airspace of Georgia;
- k) The name of an insurance Company, its address and the number of the insurance policy and the amount of the liability insurance to the passengers, baggage, cargo and third-party not being transported in the aircraft;

- l) Payment for services and State charges indicating the payer's bank and numbers of bank account.
