# AIRPORT CHARGES AT KUTAISI INTERNATIONAL AIRPORT

# **General provisions**

The prices in the tariff schedule are indicated in USD.

The prices indicated in the price list do not include taxes provided under Georgian Legislation.

With regard to Maximum Take-off Weight (hereinafter MTOW) of an aircraft any weight less than a tone will be calculated as one full tone.

#### **Special Prices**

Airlines will pay 50% of the service fee in the following cases:

- if aerodrome is used as an alternate aerodrome, while it is impossible/inadvisable to land at the aerodrome of intended landing because of the bad weather condition;
- emergency landing;
- demonstration flight;
- in case of search and rescue operations;
- if accident has happened during landing;
- emergency landing, where it is caused by an act of unlawful interference in civil aviation.

#### Flights exempted from charges

Flights which serve to a significant public interest to eradicate the conditions threatening health, human lives and/or safety, or the possibility of such conditions to occur, may be exempted from charges envisaged in this AIC.

Such conditions include, but are not limited to, earthquake, flood, fire, storm, heavy snowfall, state of emergency, war or any other force majeure conditions, which is either publicly acknowledged or confirmed by respective authority.

The MTOW applicable prices, which are indicated in paragraph C, will be increased by fifteen percent (15 %) for flights, which are either landing or departing from 22:00 to 06:00 local time. In case of domestic flights airlines pay twenty percent (20%) of MTOW applicable price indicated in paragraph C. In case of technical landing airlines are released from paying prices indicated in paragraph C, even if passengers enter transit zone. Airlines are released from paying prices applicable to passenger categories indicated in paragraph C in following cases:

- for children under two years;
- for passengers, who have not left the aircraft;
- for sky Marshalls (if they are returning with the same flight);
- if aircraft returns because of technical failure;
- for passengers of humanitarian flights;
- INAD (if they are returning with the same flight).

The MTOW applicable prices, which are indicated in paragraph D, will be increased by 15% (fifteen percent) for flights, which are either landing or departing from 22:00 to 06:00 local time.

In case of domestic flights airlines pay 20% (twenty percent) of MTOW applicable price indicated in paragraph D.

In case of technical landing MTOW applicable prices indicated in paragraph D will be reduced by 50% (fifty percent), provided that physical change (shift) of the load is not involved.

20% discount will be applicable to the Ramp services stipulated in paragraph D to the airlines who operate regular scheduled flights to Kutaisi international Airport with at least 3 weekly frequencies. During the months where the number of operated flights is less than 11, standard fee stipulated in the paragraph D will be applicable. The discount will not be applicable on technical landings.

For the above mentioned discount to be applicable to the airline, respective clause should be included in the contract.

Airlines are released from paying parking fee in the following cases:

First 3 (three) hours of parking for charter flights and 6 (six) hours of parking for cargo flights are free of charge. Any extra time of parking will be calculated as overnight parking.

Any parking time after overnight parking will be calculated as overnight (24 hours) parking.

Any period of parking time comprising 10 overnight (24 hours) parking for a calendar month as a minimum, shall be calculated as long-term parking.

In case of long-term parking the Airline shall pay 50% of parking fee.

Airlines are released from paying parking fee in the following cases:

- if flight delay is caused by bad weather condition at the aerodrome of departure or destination;
- emergency landing;
- delay caused by technical failure of the aircraft.
