AIRPORT CHARGES AT MESTIA AIRPORT

Information effective from 01 JAN 2026.

The prices in the tariff schedule are indicated in USD.

Flights exempted from charges

Flights which serve to a significant public interest to eradicate the conditions threatening health, human lives and/or safety, or the possibility of such conditions to occur, may be exempted from charges envisaged in this Circular. Such conditions include, but are not limited to, earthquake, flood, fire, storm, heavy snowfall, state of emergency, war or any other force majeure conditions, which is either publicly acknowledged or confirmed by respective authority.

Paragraph A - Landing Fee

ACFT MTOW 0-14 ton - 2.5 USD/ton.

Paragraph B - Aviation Security Charges

Fee per departing Passenger for Domestic flights - 5 USD.

Paragraph C - Parking Fee

For Scheduled Flights (MTOW 0-14 ton)	_ _ _ _	1.5 USD x Aircraft MTOW for every hour over 3 Hours (first 3 hours is free of charge). Any time exceeding 15 minutes will be calculated as one hour. After the first free 3 hours of parking, if the stay exceeds the next three hours, the parking time will be charged as one full day (24 hours). The fee for one full day (24 hours) of parking is 70 USD.
For Charter and Cargo Flights (MTOW 0-14 ton)		The fee for one full day (24 hours) of parking is 70 USD. First 3 (three) hours of parking for charter flights and 6 (six) hours of parking for cargo flights are free of charge. Any extra time of parking will be calculated as overnight parking.

Parking reservation involves making a request to occupy the parking space at least 24 hours in advance. In this case, the fee for a one-day (24-hours) reservation is 100 USD and is payable regardless of the actual number of hours the parking space is used within the 24-hours period.

Airlines are released from paying parking fee in the following cases:

- if flight delay is caused by bad weather conditions at the aerodrome of departure or destination;
- emergency landing;
- delay caused by technical failure of the aircraft.

Airlines are released from paying passenger service fee in the following cases:

- for children under two years of age;
- flights transporting the Head of State of Georgia, as well as Heads of State of other countries on an official visit to Georgia;
- crew members (pilots, flight instructors, medical/evacuation crew, technicians);
- passengers who were refused boarding (including cases of return on the same flight);
- flights transporting rescue personnel or carrying special/critical materials;
- for technical landings.

Payment

The charges set out herein shall be payable to United Airports of Georgia LLC.
